Guenthner Scholarship Reminder

The Reuben T. Guenthner Scholarship is given in memory of Reuben T. Guenthner, a leader in Career and Technical Education (CTE) in both the state and nation. Mr. Guenthner was first a CTE student, then a secondary CTE instructor, a local administrator supportive of CTE programs, and finally a member of the North Dakota Department of Career and Technical Education from 1968 to 1995.

Mr. Guenthner was also appointed to the National Advisory Council on Career Education by President Reagan in 1982. At the time of his retirement in 1995, Mr. Guenthner was the North Dakota State Director of Career and Technical Education.

One scholarship in the amount of \$500 will be awarded in May 2025, to be used for the 2025-2026 school year. Eligible applicants must meet all the following requirements:

- •Be a graduating senior from a North Dakota high school in 2025.
- Have completed one or more career and technical education courses between grades 9 and 12; (Career and Technical Education courses may be in any of the following programs: Agriculture Education; Business Education; Family and Consumer Sciences; Information Technology; Marketing Education; Technology and Engineering Education; or any of the programs in Trade, Industry, Technical and Health Education).
- Enroll in a two-year North Dakota public, postsecondary institution.
- Enroll as a full-time student in a career and technical education program of two years or less.

North Dakota Financial Literacy Standards

North Dakota CTE, North Dakota Department of Public Instruction, and the Bank of North Dakota have been working together on the North Dakota Financial Literacy Content Standards (K-12) as a part of the North Dakota Financial Literacy Commission. The North Dakota Financial Literacy Content Standards provide educational guidelines for school and district curriculum development. They are designed to equip learners with essential knowledge and skills for managing their finances as they transition into adulthood. The standards emphasize practical skills such as balancing bank statements, saving, budgeting, managing credit, and understanding paycheck withholdings and taxation. Additionally, learners will gain proficiency in completing job-related forms, handling college expenses, navigating mortgages and rent, planning for retirement, and making informed investment decisions.

The Financial Literacy Standards are currently under development and scheduled to be completed in the spring of 2025. Schools and districts are encouraged to become familiar with these standards and should review and align local curriculum and instructional materials for full implementation in 2026-2027. The standards developed for K-8 around financial literacy will provide background knowledge for those schools that offer a high school CTE Financial Literacy course.

The standards writing committee has met twice this fall and will be releasing the standards for public comment the beginning of January. DPI will also be looking for people willing to serve on the Review Committee (scheduled to meet on February 6). The standards writing committee will meet two more times during the spring of 2025 to review public comment and make final revisions. The Public Comment survey and Review Committee application will be available on the ND DPI website under Content Standards and Upcoming Events.

Isaiah MacDonald, FCSE teacher at Mandan High School received the 2024 ACTE/FCSE Division Graduate Fellowship Award. Mr. MacDonald receives a \$2000 Scholarship to use towards furthering his education at North Dakota State University (NDSU) as a graduate student in Family & Consumer Sciences Education (FCSE). Isaiah was unable to attend the conference. Mrs. Ann Dietchman, FCSE Program Supervisor at ND CTE, presented Isaiah with his award on December 16th

Dr. Mari Borr, Professor of Family and Consumer Sciences at NDSU, received recognition for her outstanding contributions to the field of FCSE. For more than 35 years, Dr. Borr has worked tirelessly to promote the field of FCSE across the nation. As a teacher educator at North Dakota State University Dr. Borr guides potential Family and Consumer Sciences teachers through the higher education system.

She has re-defined the teacher education program in such a way that students are drawn to it — some as eager college freshmen and others as seasoned adults seeking additional knowledge and skills to bring to their own middle school and/or high school classroom. The FACS education program has been revitalized and stabilized by her energy and enthusiasm for teaching and for the massive body of knowledge labeled as Family and Consumer Sciences. She continues to go out of her way to ensure that students at NDSU receive both her personal and professional support on their journey to becoming professional educators.

Dr. Borr is a recognized role model by the North Dakota FACS teachers. She develops and teaches on-site and on-line courses needed by current professionals to retain their teaching licenses and for those seeking a deeper understanding of subject matter to improve their own teaching skills. In addition to working with NDSU enrollees she has been an active participant and presenter in conferences and workshops within the state of North Dakota and across the nation. Under her leadership NDSU has become a participant in the Great Plains IDEA (Interactive Distance Education Alliance) providing students with an online option for a master's degree in FACS Education.

69th Legislative Assembly



I hope you all had a relaxing and fun filled Holiday Break. The calendar has now rolled over to 2025, which means the 69th Legislative Assembly is upon us. For the next four months, the North Dakota Legislature has the tremendous task of debating several policy bills and setting the State's budget for the 2025-27 Biennium. This article provides information on how to stay informed and be involved in the Legislative process.

First, there are a few important dates to keep in mind:

January 7th – First day of session. Governor Armstrong will also provide his first State of the State address that afternoon.

January 20th – The last day for members of the House of Representatives to submit a bill. Senators can only submit three more bills after this date.

January 27th – Deadline for Senators to submit a bill.

February 28th – Crossover: All bills must be out of the originating Chamber and crossed over to the 2nd Chamber. Legislators are on recess until March 5th.

April 9th – All Bills must be reported out of Committee in the 2nd Chamber. Bills the two Chambers disagree on are assigned to a Conference Committee to iron out differences.

May $2^{nd} - 80^{th}$ day of session. The North Dakota Constitution limits our State Legislature to 80 days per biennium. The Legislature typically tries to save a few days, in the event they need to return during the Interim to handle special business.

The Legislative process is transparent, and thanks to technology, can be accessed anywhere. The following link allows citizens to watch House of Representatives and Senate Floor Sessions and Committee Hearings; contact their local Legislators; search and track specific bills and submit written and verbal testimony. A North Dakota login ID needs to be created to track bills and submit testimony. A login is not necessary to watch video of Floor Sessions or Committee Hearings.
